The Egyptian Stock Exchange – EGX Indicators Committee approved the new amendments to the market indices on Thursday. The EGX30 index, as well as the EGX 30 CAPPED index, which includes the same companies as the EGX30 index, witnessed the exclusion of 6 companies that are non-qualified according to the current methodology, against 6 new joiners.
